Dormant Accounts!

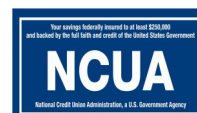
At GPP Federal Credit Union we understand accounts go unused for many different reasons. You may have moved, you may have simply forgotten you had an account with us, or maybe a family/parent opened an account for you years ago and you had no idea. While we hope you continue utilizing our services we want you to be aware of how an account can become dormant.

Dormant accounts are defined as accounts that have had no activity on shares/savings or checking for a period of 12 months or more. After 18 months of no activity a \$3.00 fee is assessed each month. Dividends posting is not considered live activity and will not protect your account from being dormant.

What can you do to prevent your account from going dormant?

- Request a withdrawal
- Make a small deposit

- One-**\$2,000 Scholarship** will be available
- **All Applicants must be a member for longer than 6 months with an active account**
- Students must have been accepted or enrolled in an accredited undergraduate or graduate program at a college, university or educational institution (minimum of 12 credits hours per semester for undergraduate and minimum of 6 credit hours per semester for graduate programs) during the Fall semester of 2024 to be eligible.
- Previous GPPFCU scholarship winners are not eligible
- Employees, Board of Directors, Supervisory and Scholarship Committee members of GPPFCU and their immediate families are not eligible.
